Meeting of the Nursing and Midwifery Board of Australia on 25 February in the AHPRA NSW Office, Sydney

The Nursing and Midwifery Board of Australia (the National Board or NMBA) is the national regulator for nursing and midwifery in Australia. It is established under the Health Practitioner Regulation National Law, as in force in each state and territory ([the National Law](#)).

The NMBA meets monthly and considers a range of matters, the most important of which are published in this Communiqué.

NMBA 25 February 2016 meeting

The NMBA February meeting was held at the AHPRA NSW Office on 25 February 2016 and the NMBA would like to extend their gratitude to the AHPRA NSW staff for their hospitality.

NMBA Sydney stakeholder forum

The forum was attended by more than 170 key stakeholders and registered nurses and midwives, and provided the NMBA with an opportunity to discuss the:

- NMBA's role and work in the regulation of nurses, midwives and students
- strategic direction and current priorities in registration, notifications and accreditation, and
- structure and partnerships in the National Registration and Accreditation Scheme.

Feedback from attendees was positive and confirmed the importance for the NMBA's to continue to hold stakeholder events to encourage interaction, participation and important dialogue with stakeholders and the NMBA.

Upcoming NMBA stakeholder engagement/information forums

The NMBA finalised a range of stakeholder events for 2016 in metropolitan and rural areas across all Australian States and Territories. Invitations will be sent by email prior to the events determined by registrant's principle place of practice. The stakeholder events/information forums are a valuable opportunity for the NMBA to engage with local nurses and midwives to ensure registrants are aware of their obligations under the National Law and any changes to registration standards, codes and guidelines.
